1 Application details

Application for temporary emissions licence (TEL) for the release of mine affected water to land discharge areas from five release points at Carmichael Mine.

2 Decision

Thank you for your application for a temporary emissions licence. Your application, which was received by this office on 23 February 2026, has been granted on different terms than those submitted

3 Reason for the decision

The administering authority has decided the application in accordance with sections 357C - 357G of the *Environmental Protection Act 1994*.

The department has determined that heavy rainfall has resulted in substantial volumes of water entering and being captured within the Mine Affected Water (MAW) storages at the Carmichael Mine which has the potential to result in uncontrolled release.

Should heavy rain persist or be predicted following the TEL period **23 February 2026** to **9 March 2026**, you may apply to extend the TEL period.

4 Human rights

A human rights assessment was carried out in relation to this decision and it was determined that the decision is compatible with human rights.

5 Review and appeal rights

You may apply to the administering authority for a review of this decision within 10 business days after receiving this notice. You may also appeal against this internal review decision to the Land Court. Information about your review and appeal rights is attached to this notice. This information is guidance only and you may have other legal rights and obligations.

6 Temporary emissions licence

This TEL commences on 23 February 2026 and ends on 9 March 2026.

The licence permits the following emission:

The release of a 173 ML per day (maximum total for all release points) of mine affected water to land.

The licence overrides the following conditions of your environmental authority, approval number EPML01470513:

- F2 (replaced by TEL F2)
- F4 (replaced by TEL F4)
- F5 (replaced by TEL F5)
- Table F1 Mine affected water release points, sources and receiving waters (replaced by Table F1 TEL)
- Table F2 Mine affected water release limits (replaced by Table F2 TEL)

In addition to the overriding conditions, this license applies new conditions TEL F30 – TEL F36 and new Table F7 TEL and Table F8 TEL to your operation for the duration of this TEL.

The following conditions apply to this licence:

TEL F2	The release of mine affected water must only occur from the release points specified in Table TEL F1 - Mine affected water release points, sources and receiving environment.
TEL F4	The release of mine affected water in accordance with condition TEL F2 must not exceed the release limits stated in Table TEL F2 - Mine affected water release limits when measured at the monitoring points specified in Table TEL F1 - Mine affected water release points, sources and receiving waters for each quality characteristic.
TEL F5	The release of mine affected water from the release points must be monitored at the locations specified in Table TEL F1 - Mine affected water release points, sources and receiving waters for each quality characteristic and at the frequency specified in Table TEL F2.
TEL F30	Releases to land must be undertaken to ensure even distribution of water across the release area and prevent: a) erosion in the vicinity of the release points b) erosion of the bed and banks of the receiving environment c) material build-up of sediment in the receiving environment; or d) environmental harm to vegetation or habitat values.
TEL F31	The release of water to land at the locations specified in Table TEL F1 must not exceed the volumes specified in Table TEL F7.
TEL F32	The release of water to land at the locations specified in Table TEL F1 must maintain the setback distances from drainage lines and sensitive receptors specified in Table TEL F7.

TEL F33	The holder of this Temporary Emissions License must undertake daily visual inspections of the land discharge areas specified in Table TEL F7. <i>Note: Site safety conditions to be considered when determining compliance.</i>
TEL F34	The holder of this Temporary Emissions License must cease all release of mine affected water to land if any of the triggers specified in Table TEL F8 are observed at any release point to land or the receiving environment.
TEL F35	Notwithstanding Condition TEL F34, the holder of this Temporary Emissions License may reduce the release (instead of immediate cessation) if Trigger 1 is observed and the risk can be managed through the redistribution of flow and/ or the implantation of minor earthworks.
TEL F36	The holder of this Temporary Emissions License must notify DETSI in writing if any of the cessation events are triggered.

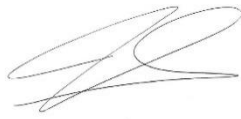
